BOOKING CONDITIONS & SIMPLE RULES

Bookings and reservations will be accepted by Varne Ridge Holiday Park subject to the following conditions;

1. The first named person is responsible for the booking and is over 18 years of age. He/she warrants that the party is not a group of young people under the age of 25 or an all male or female group. No more than the maximum number of persons as stated in the Booking Application shall be permitted to occupy the booked accommodation. Children or babies of whatever age count as one person. Bookings are from 12 noon to 11 a.m. No refund can be made for early departure.
2. Bookings are accepted on the strict understanding that persons under 18 years of age are not permitted to drink alcoholic beverages on the park, anyone found doing so will be expelled immediately from the park together with all the persons named on the Booking Application form. Young people must bring some form of identification to prove they are over 18 years of age if they wish to drink alcohol on the park.
3. Any loss or damage to equipment or property belonging to Varne Ridge Holiday Park caused by occupants of tourer, to be paid in full before departure.
4. Barbecues. No open fires or barbecues may be lit on the park, gas-fired barbecues only are permitted on the park providing they are under adult supervision at all times and kept 5m away from any structure. Please ensure not to disturb others. Do not damage grass, clear up after use and, finally, put out fire with water and eliminate any risk of **FIRE** to the surroundings.
5. Vehicles must be driven very slowly and with due care within the boundaries of the Park and must only be driven by holders of a current driving licence. Children remain the responsibility of their parents, guardians or the person signing the Booking Application Form at all times when at the Park.
6. **Ground Sheets. Solid ground sheets are not permitted as they damage the grass. Grass-friendly sheets are allowed, provided they are lifted and moved around to reduce the risk of grass damage.**
7. Dogs. All dogs to be kept on leads while on the Park and must not be a nuisance to other park guests. Dogs must not foul on Varne Ridge Holiday Park property and any accidents must be cleaned up by the dog owner.
8. Disturbance. Please respect the peaceful atmosphere of the Park and do not disturb other Park guests.
9. Electric Hook-ups. 10-amp supply is provided. This will trip out if too many appliances are used. If this happens, please request assistance.
10. Personal Property Left Behind. Any personal property left at the end of a holiday will be returned at owner's risk on receipt of postage and packing cost.
11. The Management accepts no responsibility for theft, damage or injury to any person or property whilst on the Park. We reserve the right to remove, without refund, those who fail to abide by these simple rules.
